First aid:

Skin or Clothing Contact: Remove all contaminated clothes and shoes.

Eye Contact: Flush eyes with tap water for at least 15 minutes. Consult an ophthalmologist.

If Inhaled: Remove from exposure area to fresh air immediately. If breathing has stopped, perform artificial respiration. Keep person warm and at rest. Treat symptomatically and supportive.
